

Westbury Water District.

Public notice is hereby given that, a petition in writing, with map and plan of method of construction, having been filed with the undersigned, the Town Clerk of the Town of North Hempstead, Nassau County, New York, asking that a water district be established within the following described territory in said town, as provided by Article 13 of the Town Law (Consolidated Laws of 1909), a meeting of the Town Board of the said town will be held at the house of Westbury Hook and Ladder Company, at Westbury, in said town, on **THURSDAY, FEBRUARY 9TH 1911,** at 2:30 o'clock in the afternoon, for the purpose of considering the said petition and taking final action thereon. The territory which it is proposed to incorporate into the said water district is bounded and described as follows:

Beginning at the northeast corner of the district, at a stone monument on the east side of the highway leading from Wheatly to Westbury, marking the boundary line between the townships of North Hempstead and Oyster Bay, as said line was surveyed and monumented about 1880, said monument being just south of the house of Herman B. Duryea, and running thence westerly passing a short distance south of a large button ball-tree at the southeast corner of said dwelling-house to a stone monument on the south side of the highway running westerly past the house formerly occupied by Dr. John Mann, now by Thomas Regan, at the northeast corner of the property of Benjamin D. Hicks; said line crossing the property of the aforesaid Herman B. Duryea, the property of Foxhall Keene and the property of W. W. Cocks, and running south of the house formerly occupied by Dr. John Mann; thence southerly along the eastern boundary of the property of Benjamin D. Hicks, to a stake at the angle on the division line between the property of the said Hicks property and the property of W. W. Cocks; adjacent to the property of the estate of the late J. P. Kelsey; thence easterly along the division line between said Cocks' property and the property of the said Kelsey estate; to a stake at the northeast corner of the aforesaid property of the said Kelsey estate; thence southerly along the eastern boundary of the property of the said Kelsey estate to a stone monument on the north side of the highway leading from Kelsey's store to Westbury Pond opposite the eastern boundary of the said Kelsey estate property; thence westerly, along the center of the said highway, to a large oak tree on the south side thereof, opposite the eastern boundary of the property of J. T. Brady; thence southerly along said Brady's eastern boundary, to a stone monument on the east side of the highway

thence southerly along said Brady's eastern boundary, to a stone monument on the east side of the highway leading southerly from Kelsey's store, known as the Roslyn and Glen Cove road, opposite Brady's east line; thence southerly along the center of said Roslyn and Glen Cove road, now known in part as Ellison avenue, as it winds and turns, to the center of the Old Country road, so-called, crossing the Jericho turnpike and the Long Island Railroad; thence easterly along the said Old Country road and following the division line between the townships of North Hempstead and Hempstead, to the intersection of Grand Boulevard; thence northwesterly, along the center of Grand Boulevard, to the intersection of Union avenue at Ketcham's corner; thence northwesterly along the center of Union avenue or Brush Hollow road, to the division line between the township of North Hempstead and the township of Oyster Bay indicated by a monument; thence northwesterly along the said township line marked by stone monuments on the Brush Hollow road or Union avenue, on the south side of the Jericho turnpike, and on the hill east of the house now or formerly of Oliver Titus, to a stone monument on the east side of the highway leading from Wheatly to Westbury, the place of beginning at the northeast corner of the district.

The minimum amount of money which it is proposed to expend in the construction of a water system in the said proposed district is sixty thousand dollars, (\$60,000.00).
